#### NCR FSMA Annual Conference

There's also a chance to sign up to record a short "poster" or "powerpoint" presentation. You would have five minutes to talk about your research or projects. There won't be a set time for people to view these during the conference, but the videos will be available before and after the conference.

#### FDA Updates

Frank Yiannas, FDA Deputy Commissioner for Food Policy and Response, reflected on some of the strides the FDA made last year in protecting the safety of human foods, which they plan to continue building on this year.

The FDA wants to remind produce stakeholders that the Agency previously announced its intention to exercise enforcement discretion for all of the agricultural water requirements for covered produce (other than sprouts). This includes exercising enforcement discretion related to the January 26, 2022, compliance date for the pre-harvest, harvest and post-harvest agricultural water requirements in the FDA Food Safety Modernization Act (FSMA) Produce Safety Rule for the large covered farms.

#### Resources and Virtual Events from Partners

North Dakota State University (NDSU) Extension again will host the <u>Field to Fork "Wednesday Webinar" series</u> starting February 16. Experts from across the region (including many NCR FSMA partners) will provide information about growing, preserving and preparing specialty-crop fruits and vegetables safely in this seventh annual webinar series.

The webinars will be held online from 2 to 3 pm Central time through April 20. The webinars are free of charge but pre-registration is required.

The Extension Community Food Systems Program in Wisconsin and the Wisconsin Women's Business Initiative Corporation are piloting a virtual <a href="Spanish-language food entrepreneur">Spanish-language food entrepreneur</a> showcase. Topics will include importation, developing a market, and growing a business incrementally. While the program is targeted outreach to Spanish-speaking audiences in Wisconsin, Spanish-speaking food entrepreneurs from other states are welcome to participate.

A <u>virtual HACCP course</u> will be delivered by Nebraska Extension, on February 15 and 17. The cost is \$300/person. Participants will gain an understanding of HACCP regulatory requirements (FDA and USDA-FSIS), HACCP plan development, and HACCP system implementation. The course has multiple opportunities for discussion and ample time allocated for questions, examples, and case studies. At the end of the course, participants will receive proof of course completion with the seal of the International HACCP Alliance.

The CONTACT Team is delighted to bring you "Cyclospora Facts and What You Can Do Right Now", on February 9, at 2:30 pm Central time. This webinar will feature produce safety experts Drs. Kali Kniel and Michelle Danyluk for a live one-hour presentation, followed by 30 min Q&A. Registration is required.

A report from the Joint FAO/WHO Expert Meeting on Microbiological Risk Assessment (JEMRA) on the <u>Prevention and Control of Microbiological Hazards</u> in Fresh Fruits and Vegetables has been released. This is part 3 of a larger group and covers Sprouts. The meeting was held virtually last November.

# FDA Proposes Changes to FSMA Rule to Enhance Safety of Agricultural Water Used on Produce



On December 2, the U.S. Food and Drug Administration issued a <u>proposed rule</u> that aims to enhance the safety of produce. It proposes to require farms to conduct comprehensive assessments that would help them identify and mitigate hazards in water used to grow produce. This is the latest step in the agency's implementation of the FSMA, and

it <u>proposes to replace some of the existing requirements</u> for agricultural water in the PSR. The FDA is proposing a <u>revision to Subpart E</u>.

<u>Questions can be submitted via email</u>. Currently only simple clarifying questions may be answered during this time of deliberation.

<u>Comments and feedback can be submitted online</u>. The comment period is open until April 5, 2022. Growers, educators, regulators, and others are all encouraged to submit feedback.

The <u>Agricultural Water Assessment Factsheet</u> and the <u>Expanded Table on Factors to be</u> <u>Considered as Part of Agricultural Water Assessment</u> are now available in Spanish.

#### Meetings to Discuss the Proposed Water Rule Changes



<u>Two virtual meetings</u> have been scheduled by the FDA to discuss the proposed changes. The first meeting will be held February 14, 2022, 10:45 am to 6:45 pm Central time, and the second meeting will be held February 25, 2022, 7:45 am to 3:45 pm Central time.

PSA will be hosting a series of "<u>Subpart E Office Hours</u>" in February to give PSA Trainers, extension educators, and others working with growers a platform to discuss the proposed Subpart E requirements and the impact it may have on produce growers. Dates and registration links are on their website.

The Michigan Department of Agriculture & Rural Development and NASDA are co-hosting a meeting geared towards growers. The <u>Zoom webinar</u> will be on March 2, from 12:00 noon – 1:00 pm, Central time. No registration is required. FDA officials will give a brief presentation and be available to answer questions.

### Funding Available

<u>Funds are available</u> to pay for educator/regulator professional development and for the trainer sharing program. In most cases, the NCR FSMA will reimburse you for expenses after the event. Stipends are \$500 each for the professional development funds and trainer sharing program. Each state may apply for one stipend for each program per year (September through August). If not all the funds have been requested by July, states may apply for additional stipends.
