USDA Funding

USDA Announces [Framework for Shoring Up the Food Supply Chain and Transforming the Food System to Be Fairer, More Competitive, More Resilient](#). These efforts to create more and better markets will benefit both producers and American consumers through fairer prices, as well as address longstanding issues intensified by pandemic.

In early June, the U.S. Department of Agriculture announced details of a framework to transform the food system to benefit consumers, producers and rural communities by providing more options, increasing access, and creating new, more, and better markets for small and mid-size producers. The announcement builds on lessons learned from the COVID-19 pandemic and supply chain disruptions caused by Russia's war in Ukraine. This announcement also provides additional details on the June 2021 announcement to strengthen critical supply chains and address longstanding structural challenges that were revealed and intensified by the pandemic.

The funding includes:

[\\$200 million for Food Safety Certification for Specialty Crops Program](#) for specialty crop operations that incur eligible on-farm food safety program expenses. These operations incur significant costs to comply with regulatory requirements and market-driven food safety certification requirements each year and getting these certifications opens new market opportunities for the farmers. The ongoing economic challenges due to the COVID-19 pandemic have made meeting those requirements even more financially challenging and more important to have access to additional markets.

AFRI Funding

NIFA is excited to share with you the funding opportunity announcement for a new crosscutting AFRI program area priority. Note applications will be accepted on a rolling submission basis, and as of June 6, 2022, NIFA has not assigned a deadline for A1712.

In FY 2022, NIFA requests applications for the Agriculture and Food Research Initiative (AFRI) [Rapid Response to Extreme Weather Events Across Food and Agricultural Systems](#) (A1712) program area priority. **A1712 is designed to rapidly identify and implement strategies to protect the nation's food and agricultural supply chains and the people who support them during and after hazardous events.** Events may include droughts, heat waves, wildfires, tornadoes, floods, hurricanes, tropical storms, and blizzards. These events often disrupt agricultural, forestry and rangeland production systems, and innovative Extension and applied research efforts are needed to alleviate the impact of weather-related disasters. Proposed projects must provide solutions that can be rapidly adopted by end-users. Projects are also expected to include an evaluation plan to measure solutions. Priority will go to (i) applicants that integrate youth and adult volunteer development and (ii) applicants that support or enhance existing educational materials that address disasters and naturally occurring hazards without duplicating existing efforts.
