FDA Updates

On February 15, the Senate confirmed Dr. Robert Califf as the next commissioner of the Food and Drug Administration, and he was sworn in on February 17. He previously served in this role during the Obama Administration. Former Acting Director Janet Woodcock will remain with the agency as the principal deputy commissioner.

K-State

The <u>Extension Associate</u> will respond to questions from Kansas Extension personnel and produce growers related to produce safety and assist with regulatory requirements. The position will provide assistance with carrying out on-farm produce safety assessments and onfarm food safety plans. The Extension Associate will coordinate and implement produce safety training across the state of Kansas.

<u>Funds are available</u> to pay for educator/regulator professional development and for the trainer sharing program. In most cases, the NCR FSMA will reimburse you for expenses after the event. Stipends are \$500 each for the professional development funds and trainer sharing program. Each state may apply for one stipend for each program per year (September through August). If not all the funds have

been requested by July, states may apply for additional stipends.
