FDA Updates



The FDA is asking stakeholders, including technology providers, public health advocates, entrepreneurs, and innovators from all disciplines and from around the world, to develop traceability hardware, software, or data analytics platforms that are low-cost or no-cost to the end-user.

The Challenge ends July 30.

In early July, the U.S. Food and Drug Administration released a Cyclospora Prevention, Response and Research Action Plan that outlines FDA's strategy for reducing the public health burden of foodborne cyclosporiasis in the United States caused by *Cyclospora cayetanensis* (*C. cayetanensis*) in both domestically grown and imported produce.

"One year ago the U.S. Food and Drug Administration released the New Era of Smarter Food Safety Blueprint. During the past 12 months, we've made significant progress in working toward the goals outlined in the blueprint, even in the midst of a pandemic.

The blueprint gives shape to the New Era of Smarter Food Safety initiative that the FDA announced in April 2019 to keep pace with the rapidly evolving environment in which foods are being reformulated, new foods and new production methods are being realized, and food delivery systems continue to evolve...

Working together, we **will** bend the curve of foodborne illness in this country, using the right technology, the best data, and the most consistent oversight. Consumers deserve no less."

Reminder from Kristin Esch

A reminder of a resource available to you. For farm inspections, FDA investigators and state inspectors can request an appointment with the Regulator Technical Assistance Network by [sending a request](#). If you have any questions please [contact Kristin Esch](#).

Requests should be submitted in advance of the inspection, preferably 7 days in advance, to allow for time to find and schedule an appropriate Subject Matter Expert. In the request, the investigator or inspector should include:

- Investigator or inspector name, agency, and contact information;
- Date and time of the planned inspection;
- If known beforehand, the commodities grown, harvested, packed, or held at the farm.

[Small Fruit Certification Course](#) from the Southern Center

Do you occasionally get questions about produce safety certifications and regulations, but don't have time to take a multiday course? This free two-hour course may be for you. The Small Fruit Certifications course provides Extension agents and specialists with a broad overview of certifications and regulations affecting small fruit producers in the southern region. The course covers the basics of the National Organics Program, Certified Naturally Grown, Primus Global Food Safety Initiative, United States Department of Agriculture, Good Agricultural Practices, and the Food Safety Modernization Act. Upon completion, participants receive a certificate of attendance. The program was developed by Auburn University, the University of Georgia, and Clemson University and sponsored by the Southern Region Small Fruit Consortium.

NECAFS and the Center for Agriculture and Food Systems at Vermont Law School recently announced the release of additional educational resources for farmers and food producers as part of the FSMA legal research project.

Available at elsi.necafs.org, the new resources answer key legal questions about:

- FSMA PSR Implementation and State Laws;
- Understanding When a Produce Market Intermediary is Subject to FSMA; and,
- Interactions Between the FSMA PSR and Other Laws that May Apply to Produce Operations.

The mission is to identify and aggregate individual practitioner and educational resources to improve the competencies of food systems practitioners through various levels of learning in order to advance food systems development.
