## **Partial Stop Work Order**



Notice of Award has been revised to restrict all activities that involve face-to-face interaction under produce CAP grant due to the Coronavirus/COVID-19 pandemic. This applies to inspections, on-farm readiness reviews, on-farm education or technical assistance activities, and any in-person education & outreach activities - including trainings. This restriction applies regardless of the authority being used to conduct inspections. This restriction will be in effect until further notice. If there is a need to revise objectives, timeframes, and budgets due to this restriction, grantees are to contact Program Official and Grants Management Specialist to discuss options and to obtain guidance on the submission of a prior approval request.

### What now?



- All non-face-to-face activities should continue
  - Are there activities that can now be done virtually?

- Diversion of staff to non-produce activities
  - Cannot use CAP funds for their salary, travel or any other expenses incurred
  - Produce CAP staff need to continue doing Produce
     CAP work

## **Redirection of Field Staff**



- Annual Report Drafting
  - Assessment of inventory and inspection aggregate data
- Program Budget evaluation
- Assessment of Jurisdictional Self-Assessment (JSA), Strategic Plans and Program SOPs
  - Evaluation and incorporation of best practices
    - Produce Assignment, Program Guidance, IOM, RRT Best Practices
    - Incorporation of emergency response and recall plans
- Staff training to further produce knowledge
- Farm Inventory verification via phone
- Participation on NASDA Workgroups
- Coordination with other programs and FDA
- Virtual Technical Assistance and Farm Education
