


Differences of Audits and Inspections

Audit

- Usually points based.
- Annual
- Crop Specific
- Consequences of failure are loss of sales

PSR Inspection

- NOT points based.
- May or may not be annual
- Covers whole farm
- Consequences of failure may be a fine, recall or closure.





Why Might a Farmer Want an OFRR?

- It is voluntary, confidential and free.
- It helps align what they're doing to what's required in the rule.
- It helps them figure out what they're missing.
- It provides personalized discussion on their farm food safety activities.
- Notes taken remain the property of the farmer (no FOIA-able records)
- It will improve the farmer's readiness for a PSR inspection.

§ 112.12(b) You may establish and use an alternative to any of the requirements specified in paragraph (a) of this section, provided you have adequate scientific data or information to support a conclusion that the alternative would provide the same level of public health protection as the applicable requirement established in this part, and would not increase the likelihood that your covered produce will be adulterated under section 402 of the Federal Food, Drug, and Cosmetic Act, in light of your covered produce, practices, and conditions.	Support the alternative (see § 112.12(a) and § 112.49) with scientific data or other information. The support must include evidence that • the alternative provides the same level of public health protection as use of the relevant value in the codified Rule. • the alternative does not increase the likelihood of adulteration compared to the relevant value in the codified Rule in light of practices and conditions on the farm.	If an alternative is used, documentation is available in farm records, in the scientific literature, or through a third party. The documentation is in compliance with Subpart O
§ 112.12(c) Scientific data and information used to support an alternative to a requirement specified in paragraph (a) of this section may be developed by you, available in the scientific literature, or available to you through a third party. You must establish and maintain documentation of the scientific data and information on which you rely in accordance with the requirements of subpart O of this part. You are not required to notify or seek prior approval from FDA regarding your decision to establish or use an alternative under this section.	Keep documents or other records to support the validity of the alternative and appropriate use of the alternative. When can I get an OFRR?

OFRRs can be scheduled right now.

 USUALLY they happen during harvest, so they'll take place in the season.

How many people will conduct an OFRR?

- We expect most OFRR teams to include 2-3 people.
- Unless you're part of one of the trainings, those classes are currently at about 25 people!

How do I sign up for an OFRR?

 Send a request to Heather Borden at MSU Extension.

- Use the subject "OFRR Request".
- Reference your farm address and contact info.

Will someone just show up for an OFRR?

NO – this is a voluntary program you register for.

It's not only voluntary, its also free!

Will signing up put me on some sort of a list for an inspection?

Not intended to!

 And it may even drop you lower on the list of farms needing an inspection

Will they review my records during an OFRR?

 NO – the OFRR will ask if you are keeping the records required by the PSR, but will not perform a records review.

What if they find something wrong during an OFRR?

- Egregious Conditions
 - A practice condition, or situation on an farm or in a packinghouse that is reasonably likely to lead to:
 - Serious adverse health consequences or death from the consumption of or exposure to covered produce
 - An imminent public health hazard is posed if corrective action is not taken immediately
- If an "Egregious Condition" is found reviewers have been trained in a course of actions to follow with the grower
 - If product has not entered commerce, and the issue can be immediately addressed, FDA will **not** be notified

Is anyone else offering this service?

- OFRR's will be run by State Departments of Agriculture
- Eventually, the OFRR materials will be available online, and other consultants or growers can use as they wish

Results so far...

- 75 OFRRs Reported in NCR for 2018
- 28 Confirmed Covered Farms.
- All but 8 farms either meet minimum standards, or need minor improvements.

Most In Need of Improvement

- Worker Training
- Harvest Sanitation
- Health and Hygiene

Areas of Concern

Worker Training

Inadequate records.

Harvest Sanitation

- Inadequate cleaning and sanitizing of contact surfaces.
- Inadequate cleaning of reusable containers.

Health and Hygiene

- Inadequate worker training.
- Inadequate sick leave policy.
- Inadequate visitor notification.

What type of assistance do farms need to meet compliance?

Time (37 Responses)

Technical assistance (39 Responses)

Significant monetary investment (3 Responses)



On-Farm Readiness Review Summary

- Final tool will be used by extension and others as educational tool for growers and packers under the Produce Safety Rule to use for selfassessment.
- Utility of the tool will improve after FDA releases guidance
